



The Dark History of Medical Experimentation on Black Americans from Colonial Times to the Present



History

- Some highlights:
 - Immunity belief
 - Malaria, yellow fever, smallpox, typhoid, heat exhaustion and more
 - Physical and emotional pain
 - Justified torture, brandings ,beatings and painful medical procedures

Marion Sims

- Experimented on:
 - Black children including puncturing bones and moving them into new positions
 - Black women pre and post-natal, with no anesthesia
- Sims's believed that Black people didn't experience pain like White people
- Developmental differences between African Americans and Caucasian Americans
 - that African American "skulls grew too quickly around their brain"

History of Distrust



Tuskegee Syphilis Study

- Sick men tracked until death ensure autopsy
- Study went on for 40 years during which men were denied treatment
- Became iconic symbol of racialized medical abuse and a source of the fear of medical treatment



History of Distrust

Henrietta Lacks

- went to Johns Hopkins Hospital seeking treatment for a tumor on her cervix in January 1951 later that year died
- Cells from her tumor were harvested without her consent and have been used in biomedical research ever since
- For decades family was unaware her cell known as "Hela" was being used

s a pediatric chief resident at Indiana University's medical school, Dr. Chaniece Wallace had a list of blessings. This fall, the 30-year-old was interviewing for jobs around the country — and preparing for the birth of her first child.

On Oct. 20, baby Charlotte was born a month premature. Days later, the new mom died.

Her death shook the maternal health care community and has left a "heaviness in our hearts," says pediatric chief resident Dr. Amalia Lehmann. She's reminded of her "beloved" friend



The death of Dr. Chaniece Wallace highlights a stark racial disparity in maternal mortality rates. Nationwide, Black women are at least twice as likely to die in pregnancy, childbirth or within a year of pregnancy as white women.



Dr. Susan Moore and COVID-19

- Documented her final days of life in raw, emotional Facebook posts.
- Indiana physician claimed fellow physicians ignored her COVID-19 symptoms and threatened to send her home.
- "You have to show proof that something is wrong with you for you to get the medicine," Dr. Moore said in a video. "I put forward and I maintain, if I was white I wouldn't have to go through that."
- The COVID-19 pandemic exposed America's long history of unequal medical treatment for Black patients and has killed more at higher rates





Weapons of Math Destruction (WMD)

- Discusses understanding the impact of mathematical sciences and data misuse
- Models being used to help judges sentence fairly but ended up creating more bias
- Bias in algorithms behind:
 - employment application screeners
 - policing and sentencing
 - workplace wellness programs
 - credit scores
- WMDs can encode racism into an algorithm or enable predatory companies to advertise selectively to vulnerable people
- Disarming models

Weapons of Math Destruction

- Due to racist policing practices such as stop and frisk, people of color have encounter with police much earlier than white people
- O'Neil writes,

"Many WMDs create feedback loops that perpetuate injustice. Recidivism models and predictive policing algorithms—programs that send officers to patrol certain locations based on crime data—are rife with the potential for harmful feedback loops. For example, a recidivism model may ask about the person's first encounter with law enforcement. Due to racist policing practices such as stop and frisk, black people are likely to have that first encounter earlier than white people. If the model takes this measure into account, it will probably deem a black person more likely and assigned a high risk score"
